Mr. Tangren has vast experience in the field of automotive defect litigation, having represented plaintiffs in multistate class actions over defective electronic throttle systems, engine blocks, brake cylinders, and other vehicle components. Mr. Tangren has also won victories for class plaintiffs in other antitrust and consumer actions at both the trial and appellate level.

Among other recognition, he has been named a class action *Super Lawyer* in Illinois for his effective representation of consumer classes in automotive and other cases, was named by the National Trial Lawyers as a “Top 40 Under 40” attorney in 2012, and an Emerging Lawyer by the Law Bulletin Publishing Company. Mr. Tangren is frequently asked to speak on topics relating to class action litigation.
